

## NOVA BANK RISK RATING REPORT (2024)





## INDEX MOVEMENT


The NGX All-Share Index and Market Capitalization depreciated by 2.94% and 2.26% to close the week at 102,353.68 and N62.851 trillion respectively.

Similarly, all other indices finished lower with the exception of NGX MERI Value, NGX Consumer Goods, NGX Growth and NGX Sovereign Bond which appreciated by 0.70%, 1.33%, 0.15%, and 0.04% respectively while the NGX ASeM closed flat.
